

# Privacy & Security

This document helps you understand what personal information we collect about you, how we collect it, what we use it for, and what rights you have regarding your personal data.

## WHAT INFORMATION WE COLLECT?

### Personal Information

The first type of information is information that identifies or may reasonably identify an individual with reasonable effort (“Personal Information”). Personal Information which is being gathered may consist of the following:

- your first and last name,
- date of birth,
- E-mail address and
- Phone number

### How we use your personal data?

We use your information to keep track of your account and to help set up your account and to contact you for future promotion and new update regarding our service.

- To set up, manage and update your account;
- to communicate with you and to keep you informed of our latest updates to our Services and special offers;
- To provide you with a responsible gaming environment;
- To detect and prevent fraudulent and illegal activity or any other type of activity that may jeopardize or negatively affect the integrity of the Services, including by identifying risks associated with your activity on our Services;
- To investigate violations of our policies and User Agreement as well as enforce our policies and the User Agreement;
- or Customer Relationship Management purposes, and to support and troubleshoot the Services and to respond to your queries;
